Minutes of the Meeting of the Council held at the Eight Ash Green Village Hall, Spring Lane, Eight Ash Green on Wednesday 11 September 2024 at 7.30pm.

55-24/25 To receive Apologies for Absence and confirm acceptance of those apologies

Apologies were received from Cllrs Nokes and Smith, and acceptance of these apologies was confirmed.

56-24/25 Declaration of Interests

There were no Declarations of Interest.

57-24/25 Public Participation

Mr Chambers from the Eight Ash Green Cricket Club said that the season had ended better than it had started, with success on the field and much better weather. He said fundraising efforts had raised nearly £30,000 towards the refurbishment of the pavilion and he hoped that the interior work would start this autumn. He said the last match of the season would be held on the coming weekend and all were welcome. He said the Sunday would be a special occasion to thank all those who had donated to the pavilion fund.

He said he had met with the Chairman and Mr Winterbourne to look at ways to mitigate against adverse weather in the future, given how wet the 2024 spring had been and how that had affected play. He said possibly trees would be planted strategically.

He said there was much optimism at the Club and money in the bank, and fingers were crossed for better cricket weather next year.

60-24/25 Report from County Councillor and Ward Councillors, if present.

Cllr Dennis Willetts gave apologies from Cllrs Barber and Naylor and said they were attending a meeting of the full City Council.

He referred to the finances of the City Council and said they were looking perilous. He said unless considerably more money than in the past was passed on by central Government, services would be under pressure.

He said Cineworld, a key tenant at the Northern Gateway, had gone into administration and would be pulling out of their lease. He said without this anchor tenant, other tenants would ask for a rent reduction. He said it did raise questions about a Council's involvement in property development.

He said street services would certainly not improve and more would be known in December.

He referred to various planning applications regarding vehicle movements and said there was limited control over these movements. He said the Local Authority could put a limit on the number of movements to avoid a backlog if the vehicles were involved in waste collection. He said if they were for any other industrial purpose, for example composting, permission could be given or refused, but vehicle movements could not be limited.

He referred to the Wormingford site where ECC had issued a Stop Notice for the composting facility. He said this had been appealed and a planning application submitted to continue the activity which had been rejected.

He said there were two appeals on the same site covering different issues which would be dealt with separately. He said the Inspector hearing the appeal had said that a decision on that should be made after the planning application for retrospective permission had been decided. He said therefore in the meantime the activity could continue but no mitigating factors could be implemented.

He said the retrospective application for the composting facility was awaited and the Planning Inspector would consider this.

He referred to the CSH site and said CSH had expanded their capacity so the number of lorry movements was likely to increase from 150 to 250 or more. He said there would be a significant number of movements through the village over the coming year.

He referred to the additional composting and biomass movements through the village during spring and summer over which there was no control at all.

He said there were many issues concerning traffic through the village and mitigating would be incredibly difficult.

Cllr Jardine said he had met with Colchester City Council officers from the Planning department regarding the Neighbourhood Plan. He said Cllr Nokes and Triolo had agreed to work with him with Cllr Dennis Willetts offering to act as an advisor. He said they were hoping to consider reviewing the Plan up until 2041.

Cllr Jardine referred to a meeting with West Bergholt Parish Council, where signs for Argents Lane had been discussed.

The Council noted the reply from Simon Cairns of Colchester City Council regarding a query about planning applications.
