86-24/25 To receive Apologies for Absence and confirm acceptance of those apologies

88-24/25 Public Participation

89-24/25 To agree as a true record the minutes of the Meeting of the Parish Council held on Wednesday 9 October 2024.

90-24/25 To note progress on matters mentioned in the minutes

Cllr Jardine said he had attended the recent meeting of the Festival Committee. He said that the event had been successful, with good weather and many residents enjoying the day. He said despite this however the event had made a loss and this was not sustainable. He said the very active committee is already looking towards next year and the annual grant from the Parish Council is vital. He said new volunteers for the committee had been welcomed and everyone was optimistic for 2025.

He referred to litter bins within the parish. It was noted that the Street Officer would be asked about the effectiveness of the collection service provided now by Colchester City Council. It was noted that Cllr Manda would contact the Aspen Walk Management company regarding the bin on the new play area, which was full but was not being emptied. It was noted that the bin at the bus

stop close to the A1124/A12 junction would be added to the collection service by CCC.

Cllr Nokes said the new heather on the heath had all been planted.

Cllr Nokes said vegetation outside Halfmoon Farm had been cut back.

91-24/25 Report from County Councillor and Ward Councillors, if present.

Cllr Dennis Willetts said the latest issue of the magazine had now been published. He said he had been disappointed by the lack of contributions and hoped for more local news for the next issue.

He referred to the recent discussions about Iron Latch Wood. He said following problems with finding management for the wood, at the end of 2023 Colchester City Council had agreed to manage it. He said this management would be different to the "light touch" applied by the Parish Council to the heath. He said a very popular bike trail had been developed in the wood over the years where there was little supervision but which was very much enjoyed by those who used it. he said in general it was self-managed and provided an invaluable service for youth in the area. He said the Portfolio Holder had decided this trail would be dismantled. He said that negotiation was a better way forward and to work with those who used it. He said there was now a stay of execution until community consultation had been undertaken, which should involve the Parish Council. He said there were other alternatives that could be explored.

242149 - 16 Searle Way, Eight Ash Green Essex CO6 3QS - 2 story side extension 1st floor single story extension and single story rear extension.

It was agreed to comment as follows:

The Parish Council is concerned about whether there is sufficient space on site to manoeuvre vehicles so they can exit the site in forward gear. We would ask for clarification that this will be the case and also request that any building is only to be used in conjunction with the main dwelling, not used by third parties and not sold off as a separate entity.

The Parish Council noted concern with the decision in this case. It was noted that the Inspector found in favour of this proposal, despite acknowledging it was outside the village envelope and situated on land not allocated for development. It was noted that reasons were it was not sufficiently isolated and was continuous with the existing development, which the Council felt could set a dangerous precedent.
